

ALLOTMENT AND ISSUANCE OF 943,800 NEW ORDINARY SHARES IN THE CAPITAL OF THE COMPANY PURSUANT TO THE EXERCISE OF 943,800 WARRANTS

Unless otherwise defined, all capitalised terms used herein shall bear the same meanings as ascribed to them in the offer information statement dated 1 March 2017 issued by AsiaPhos Limited (“Company”).

The board of directors of the Company wishes to announce that the Company had on 25 July 2017, allotted and issued an aggregate of 943,800 new ordinary shares in the capital of the Company (“**New Shares**”), at the exercise price of S\$0.08 each, pursuant to the exercise of 943,800 Warrants. The New Shares are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) on 27 July 2017.
