RECEIPT OF NOTICE OF CLAIM

The Board of Directors (the “**Board**”) of **Asiaphos Limited** (the “**Company**”) wishes to announce that on 7 March 2019, the Company’s wholly-owned subsidiary, Sichuan Mianzhu Norwest Phosphate Chemical Co., Ltd. (“**Mianzhu Norwest**”) had received a notice of claim (the “**Notice of Claim**”) issued by the Mianzhu Municipal People’s Court which was filed by 20 former employees of Mianzhu Norwest who had resigned sometime in 2018 .

In the Notice of Claim, the 20 former employees are claiming severance pay amounting to RMB1.844 million (approximately S\$0.373 million).

Mianzhu Norwest’s lawyers have formally advised that there are no merits to the claim and Mianzhu Norwest will be defending the claim accordingly.

For the avoidance of doubt, the Board would like to inform shareholders that no legal proceedings have commenced at this stage.

Shareholders are advised to read this announcement and any further announcements by the Company carefully. Shareholders are advised to refrain from taking any action in respect of their securities in the Company which may be prejudicial to their interests, and to exercise caution when dealing in the securities of the Company.
